4. Pre-bid meeting shall be held at in the OGRM office, Gulmi at 12th October 2018(2075/06/26).
5. Sealed bids must be submitted to **the office of Gulmidarbar Rural Municipality, Gaundakot, Gulmi** by hand/courier on or before 12:00 PM (noon) on 25th October 2018(2075/07/08). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 25th October 2018(2075/07/08) at the **office of Gulmidarbar Rural Municipality, Gaundakot, Gulmi**. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security, amounting to a minimum of NRs 90,000 which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Bids should comply in all respects with the Instruction to Bidder included in the bid document. Non compliance with this instruction shall result in disqualification.
9. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
