- Gulmidarbar Rural Municipality** invites electronic bids from eligible bidders for the **Shree Ishwari Secondary School (16 rooms) Building Construction Works at Gulmidarbar Rural Municipality Ward No.6** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 4,41,00,000.00**
- Minimum Work experience of similar size and nature at least **one Contracts of Government Buildings Works** within the last ten (10) years, each with a value of at least **NRs. 2,65,00,000.00**
- A minimum construction experience in the following key activities:
PCC for RCC M 20 Garde or above Works = 270 cum per year
Reinforcement Bar TMT = 45 MT per year

- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- Electronic bids must be submitted to the office **Gulmidarbar Rural Municipality, Office of the Rural Municipal Executive, Gaundakot, Gulmi** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hours on 1st April, 2022 (18th Chaitra, 2078)**. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hours on 1st April, 2022 (18th Chaitra, 2078)** at the office of **Gulmidarbar Rural Municipality, Office of the Rural Municipal Executive, Gaundakot, Gulmi**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 9,20,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
